### Conditions:

- I. All pupils of primary schools from Slovenia and abroad can participate in the competition.
- II. The theme of the competition is "**Forest Animals and the Importance of the Forest**".
- III. Slovenian forests consist of about 70 different tree species, a large number of shrubs, herbaceous plants, mosses, lichens and mushrooms, as well as numerous animal species. These live in the ground, on the ground, above the ground, and on and in plants. All these plant and animal species live in balance. If this balance is broken, then the forest adapts to this over time. The forest changes. Some species disappear and others appear. The forest is also important for humans, as it is a source of our food, raw materials, a place for relaxation and recreation.
- IV. Each participant may participate with **one work**.
- V. Submitted works must be entirely the copyrighted work of the participant, for which the participant (or his/her legal representative) assumes all responsibility.
- VI. Works can be designed on a plot between **A4 and A3 format** – drawing, painting or graphics (only two-dimensional art products are accepted). Works should be sent to the school's address or in digital form in JPG format (originals can be scanned or photographed).
- VII. **SUBMISSION AND SUBMISSION OF WORKS:**
